The Trustees serve for staggered four-year terms. All Trustees reside on Long Island or in the Rockaways and have relevant utility, corporate board, or financial experience. Trustees are not compensated for their service.

In accordance with LIPA’s By-Laws, the Vice Chair is empowered to be Acting Chair in the absence, disability, incapacity, or vacancy in the office of the Chair, and shall assume the powers and perform all duties of the Chair if the Chair is unable or unavailable to perform their responsibilities for any reason.
